TO DISCUSS AND TAKE ACTION ON:

1. ORDINANCE OF THE CITY OF YONKERS, NEW YORK, ADOPTED NOVEMBER 15, 2016 DETERMINING THE TERMS, FORM AND DETAILS OF ISSUANCE OF \$23,080,000 GENERAL OBLIGATION REFUNDING BONDS-2016A AND \$11,060,000 SCHOOL REFUNDING BONDS-2016B OF THE CITY, DIRECTING THEIR PRIVATE SALE, AND PROVIDING FOR THE RIGHTS OF THE HOLDERS OF SAID BONDS AND OTHER OBLIGATIONS OF THE CITY.
2. ORDINANCE OF THE CITY OF YONKERS, NEW YORK, ADOPTED NOVEMBER 15, 2016 DETERMINING THE TERMS, FORM AND DETAILS OF ISSUANCE OF \$27,372,250 GENERAL OBLIGATION SERIAL BONDS-2016C AND \$16,000,000 SCHOOL SERIAL BONDS-2016D OF THE CITY, DIRECTING THEIR PRIVATE SALE, AND PROVIDING FOR THE RIGHTS OF THE HOLDERS OF SAID BONDS AND OTHER OBLIGATIONS OF THE CITY.
