AN ORDINANCE AMENDING THE CAPITAL BUDGET FOR THE
FISCAL YEAR COMMENCING JULY 1, 2010 AND TERMINATING
JUNE 30, 2011.

The City of Yonkers, in City Council convened, hereby

November 16th, 2010, and a public hearing thereon having been
held on Tuesday, December 7th, 2010 is hereby approved and
adopted as an amendment to the Capital Budget of the City of
Yonkers for the fiscal year commencing July 1, 2010 and
terminating June 30, 2011.

Section 2: This ordinance shall take effect immediately.
