INSTRUCTIONS FOR USING THIS FORM

Please Note:

In order to obtain this license, the location of the business must be in a C, CM or I Zoning District. If you need to obtain the zoning district of your business location, please contact the COY Department of Housing & Buildings at (914)377-6500.

Requirements:

1. Application and Police Department Affidavit must be signed by the applicant before a Notary Public.
2. Provide two (2) passport-sized photographs taken within (30) days of application date.
3. Must be fingerprinted by the Yonkers Police Department Special Investigations Unit at (914) 377-7340. See #7.
4. Return all required documents to the Office of Licensing/Consumer Protection, who shall forward application to the Commissioner of Police for approval prior to licensing.
5. Provide a copy of a valid NYS Driver's License issued by the Motor Vehicle Department. If you do not have NYS Driver's License, a copy of a Motor Vehicle issued NY State ID Card is required.
6. Submit a bond to the City of Yonkers, to be executed by the licensee and by a security company, authorized to transact business in the State of New York, in the penal sum of ten thousand dollars (\$10,000), to be approved on the faithful performance of the duties and obligations pertaining to the business so licensed.
7. A U.S. Postal Money Order in the amount of \$75.00, made out to City of Yonkers, (for the fingerprinting/ back ground process done by the Dept. of Criminal Justice Services), must be submitted with application.
7. Provide a copy of current Certificate of Occupancy that will be routed to the City of Yonkers DHB for inspection.
