3. Photocopy of New York State Vendor Certificate or Certificate Authority. If you do not have this card, call the NYS Department of Taxation at 1-800-972-1233 for information as to how to apply for the card.
4. Copy of a valid NYS Driver's License issued by the Motor Vehicle Department. If you do not have a NYS Driver's License, a copy of a Motor Vehicle issued NY State ID Card is required
