Please Note:

A supplementary license is required for each additional place of business maintained by a licensee within the City of Yonkers. Each such supplementary license will hold the same license number as the Primary Location.

If the required supporting documents are not submitted with the application, it will result in the delay and/or denial of the application.

Requirements:

1. Application must be signed by the applicant before a Notary Public.
2. Two (2) passport-sized photographs taken within sixty (60) days of application date.
3. Copy of a valid Driver's License issued by the Motor Vehicle Department. If you do not have a Driver's License, a copy of a Motor Vehicle issued ID Card is required.
4. Application fee of \$25.00 Payment may be submitted in Cash, Money Order or Business Check. Please make checks payable to The City of Yonkers.
5. No license shall be assignable or transferable. Each additional location must have a completed application And hold a valid license from this office.
6. Each license must be posted in a conspicuous place on/in the vehicle.
7. Notify this office IMMEDIATELY of any changes in the information supplied by you on this application.
