Guidelines for completing an Electrical Permit Application

- All electrical work requires a permit except for: "the replacement of lamps, ballasts, or fuses or the connection of portable devices to suitable permanently wired receptacles."
- All Fire Alarm work that has a central panel MUST be filed on a Building Permit and is handled by the Yonkers Fire Department.
- All Low Voltage work requires a separate electrical permit except for: HVAC controls in 1 & 2 Residences.
- You MUST calculate your permit fees and provide us with a completed check.
BLANK CHECKS WILL NOT BE ACCEPTED

Property and Owner / Lessee information:

- You must provide all information and fill in all spaces that apply.
- If you need help obtaining the Block and Lot numbers for the property, contact the Assessor's Office at 914-377-6200

Affidavit of Cost:

- You must have the Owner / Lessee complete, sign and notarize this section.
- The "Cost" of work must include any and all services, labor, material and equipment to complete the work. If the Owner / Lessee purchases material or provide any other assistance to complete the work, the value of those items are to be included in the "Cost".

Contractor Information:

- You must provide all information in this section and have it notarized.

Information on Work to be Performed:

- You MUST answer questions 1 through 5 as they apply to the work you are applying for. All 5 questions MUST be answered.
- Provide a brief description of the area of work and type of work to be performed.
ie: Wiring new 2 story addition, Wiring new building, Replacing fire damage wiring, Upgrading service to 200 amps, ect.

Electrical Permit Application Counts Sheet:

- You must complete this section and provide us with the number of devices and equipment being installed under this permit. If there is not a category or you need additional space, please provide this information on a separate sheet of paper.
- Any work performed that is not listed on this application or an amendment to it, will be deemed "Working without a Permit" and will be subject to Legalization Fees.
